## E. ORDINANCES: FOR FINAL PASSAGE

1. Council File No. 16,453 Pending Official File Ordinance No. 41-2024 An ordinance appropriating the sum of \$13,500,000.00 from unappropriated and unanticipated revenue for the expenditure thereof for the UPMC Park Upgrades and Clubhouse to be completed via a cooperation agreement with the Erie County Convention Center Authority acting as a sub- grantee. Pass-through funding is provided from the PA Redevelopment Assistance Capital Program (RACP) Grant.

2. Council File No. 16,454 Pending Official File Ordinance No. 42-2024 An ordinance amending Article 309 to increase the fee(s) for a license under this Ordinance and/or to increase the penalties for a violation of this Ordinance. These amendments will provide enhanced compliance of Mechanical Amusement Devices with the City and/or will provide further protection to citizens and/or the community.

## **ORDINANCES: FOR FIRST READING**

1. Council File No. 16,455

An Ordinance of the City Council of this City of Erie (The "City") Determining to incur Lease Rental Debt; evidenced by the Guaranteed Revenue Note in the Maximum Principal Amount of \$471,795.00 to be authorized and issued by Erie City Water Authority in connection with the construction, alteration and improvements to the Public Water Distribution Facilities in and about this city, including but not limited to, the Lead Service Line Replacement Project – Phase Five and paying related costs, fees and expenses; Specifying the realistic useful life of the project; Authorizing and directing appropriate Officers of the City to take certain actions and to execute certain documents, including a Guaranty Agreement, between The City, as Guarantor and the Erie City Water Authority, and the Pennsylvania Infrastructure Investment Authority; Approving the form, maximum guaranteed amounts and sources of payment of the guaranty agreement, Creating a Sinking Fund in connection with such guaranty obligations and appointing a Sinking Fund Depository; and providing for the Repeal of all Inconsistent ordinances or parts of ordinances.

#### **OLD BUSINESS**

- 1. A request of <u>proposed amendments</u> to Articles 2, 3, and 6 of the City of Erie Zoning Ordinance to amend screening language throughout the ordinance, and also define specific screening and off-street parking requirements for Short Term Rentals.
- 2. A request for local designation of the <u>Erie Federal Courthouse</u> Complex located at 17 South Park Row in the City of Erie PA as a Historic Structure per the provisions of Article 7 of the City of Erie Zoning Ordinance Historic Resource Protection.

Martin, Etal locating the retaining wall easement for **Andy's Pub** at 3860 Peach Street, Erie, PA 16501, Index (19) 061-011.0-206.00, in compliance with the attached Engineer's meets and bounds description and drawings.

4. A Resolution of Erie City Council to Accept and Support The Neighborhood Plan For The Wayne Health & Wealth Equity District Planning Area; Adopting The Recommendations and the Multiple Year Action Plan; And Providing for an Effective Date.

**WHEREAS**, the City of Erie is responsible for the preparation, adoption, and implementation, of the City's comprehensive plan; and

**WHEREAS**, on July 6, 2016 the City adopted a comprehensive plan entitled Erie Refocused according to the requirements of the Pennsylvania's Municipalities Planning Code, Act of 1968, P.L. 805, No. 247 as amended; and

**WHEREAS**, The City understands that its responsibility is to provide a framework for change. Without a framework, plan or way to measure change, the development process is reactive, leading to fragmented and uncoordinated development; and

**WHEREAS**, the City of Erie, its administration and elected officials believes that planning that is done in conjunction with residents and community stakeholders results in positive and forward-thinking outcomes and will lead to achieving the vision and goals of the City; and

**WHEREAS**, the City has created a process by which comprehensive plan recommendations can meet the objectives of proper planning while moving efficiently and effectively into implementation through due consideration by City staff and the Erie Planning Commission working with community stakeholders, neighborhood groups and interested citizens; and

**WHEREAS**, this process is referred to as the Neighborhood Planning Initiative which is designed to create specific neighborhood plans that align with Erie Refocused and are citizen driven through a robust citizen engagement program; and

WHEREAS, the Wayne Health & Wealth Equity District Neighborhood Development Plan (the Plan) has been developed through input by neighborhood groups working within the area including the Equity District's own steering committee of community residents, business owners, and leaders, the Erie Center for Arts & Technology, and the City of Erie's Love Your Block program; and

**WHEREAS**, the Plan was informed by a significant amount of public input via community meetings, stakeholder meetings, a participatory community-wide survey, as well as data collection and analysis including the collection of over 400 property condition surveys; and

**WHEREAS**, the Plan fulfills the requirements of the Neighborhood Planning Initiative and has been reviewed by the mayor, and the mayor's staff, the Department of Planning and Neighborhood Resources, and was presented at a City Council study session; and

**WHEREAS**, the Plan has been reviewed and is recommended for approval by the City of Erie's Planning Commission at their regular meeting held on June 18, 2024; and

**WHEREAS**, the council members of the City of Erie have carefully and thoughtfully reviewed the Wayne Health & Wealth Equity District Plan, it's recommendations and action plan, and are satisfied that it meets the needs of the City and fulfills the goals of the City's comprehensive plan, Erie Refocused, and the accompanying Five Year Action Plan.

**NOW**, Therefore, Be It Resolved, the City of Erie hereby adopts and commits to collaboratively implementing the Plan with BUILD Community Development Corporation and community stakeholders to improve health outcomes and quality of life for the District.

- A resolution authorizing and directing the Proper City Officials to execute a Towing Agreement with **McMillens Towing & Transport, Inc.**, 2342 Warfel Avenue, Erie, PA 16503. The term of the Towing Agreement will commence on the date of approval by City Council, for a term of four (4) years with a provision for a one (1) year extension. McMillens Towing & Transport, Inc. will provide city towing services for the Bureau of Police of the City of Erie per **Codified Ordinance 527.04**.
- 6. A resolution authorizing and directing the Proper City Officials <u>Eddie's</u> Collectibles, 1039 West 18<sup>th</sup> Street, Erie, PA 16502. The term of the Towing Agreement will commence on the date of approval by City Council, for a term of four (4) years with a provision for a one (1) year extension. Eddies Collectibles will provide city towing services for the Bureau of Police of the City of Erie per Codified Ordinance 527.04.

- 7. A resolution authorizing and directing the Mayor and other appropriate City Officials to execute an agreement between the City of Erie and Erie Community Foundation whereby the City will make available Community Block Grant (CDBG) funding I the amount of \$20,000.00 to carry out the designated activity outlined in the amended FY23 CDBG plan.
- 8. A resolution authorizing and directing the Mayor and other appropriate City Officials to execute an agreement between the <u>St. Martin Center</u> whereby the City will make available Emergency Solutions Grant (ESG)) funding in the amount of \$55,353.86 to carry out the designated activity outlined in the amended FY20 plan.
